After graduating from South-Doyle High School in Knox County, Tennessee in 2007, Andrew studied political science and philosophy at the University of Tennessee in Knoxville, Tennessee. In 2011 Andrew obtained a Bachelor of Arts Degree from the University of Tennessee. In 2012 Andrew began his studies at the University of Tennessee College of Law. While at the University of Tennessee College of Law Andrew focused his studies on transactional law with an emphasis on estate planning.
